Why is this Different from Other RRR Machine Refrigerant Flushing Methods? The RRR machines are limited mechanically (size of valves, hoses, and fittings) from producing adequate flow and velocity; and also limited chemically by the very low boiling points of the "host" refrigerants (gas will not flush out any oils or debris). Poor Physical and Chemical capabilities aside, is this really the kind of dirty work you want your expensive and EPA required RRR machine doing?
